Your services will be evaluated regularly by ODW's purchasing department.




Reliability in delivery

In order to be able to render your services reliably, ODW requires the punctual delivery in line with the deadline given in the order. Packaging and/or shipping regulations must be strictly complied with. Should it be foreseen that the required delivery deadline cannot be met, the procurement management of ODW should be informed immediately. The measures taken must be documented and shared with ODW. In emergency cases, all measures are subject to shortcuts in order to comply with the normal delivery times, so as to fulfil the wishes of the customer.

Supplier management

Supplier management signifies the proactive organisation of all supplier relationships with the company across all areas, by means of better cooperation with the direct supplier (but also pre-suppliers), with the objective of developing, providing and manufacturing products or services better, faster and at a lower cost. It is crucial for successful supplier management that the objectives for this are clearly determined.
